## Order

WHEREAS, the institution, namely, SHRI SANSKARDHAM B.ED. COLLEGE, RAIL NAGAR-3, BAJRANGWADI MAIN ROAD, JAMNAGAR ROAD, RAJKOT, GUJARAT was granted recognition by WRC, NCTE for B.Ed. course of one year duration with an annual intake of 100 students vide order No.WRC/5-6/88/2006/C-11468 dated 01.03.2007.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW02258/323253/2015/140662,65,68, 70,72,73,74,76 dated 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2015-2016.
- 3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 26.08.2016.
- 4. AND WHEREAS, in response to the aforesaid show cause notice, reply not submitted by the institution.
- 5. AND WHEREAS, the matter was placed in the 366<sup>th</sup> meeting of WRC held on July 12<sup>th</sup> & 14<sup>th</sup> 2022, and the Committee has decided the following:-

"The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

- Reply of SHOW CAUSE NOTICE issued on 26.08.2016 not received within stipulated time
- Certified copy of land documents to be submitted.
- Latest approved faculty list as per the NCTE Regulations to be submitted.
- The institution has not uploaded necessary information on its website.
- Originally notarized CLU, (Certificate of Land Use) Non-Encumbrance Certificate, Approved Building Plan and Building Completion Certificate issued by Engineer of Rural Engineering Service or PWD Engineer is required to be submitted.

FDRs of Rs.5 lakhs as Endowment Fund and Rs.7 lakhs as Reserve Fund in joint operation with Regional Director, WRC (NCTE) to be submitted.

In view of the above, the Committee decided to issue final show cause notice to the institution before withdrawal of recognition of B.Ed. programme u/s-17 of the NCTE Act. Reply should reach this office within 30 days from the date of uploading the minutes on the website of NCTE.'

- AND WHEREAS, in response to the minutes uploaded on website, the institution has submitted the reply of show cause notice vide letter dated 13.08.2022 received in WRC on 29.08.2022.
- AND WHEREAS, the matter was placed before WRC in its 370th meeting held September 10 & 12, 2022 and the Committee decided as under:-

"The original file of the Institution along-with other related documents, representation dated 13.08.2022 from the institution in response to final show cause notice for compliance of revised recognition order as decided in 366th WRC meeting, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed that the institution has fulfilled the criteria laid down under extant NCTE Regulations, 2014 (as amended time to time)

In view of the above, the Committee decided that recognition to B.Ed. course be continued. Hence, order of continuation of recognition to B.Ed. course of two years duration be issued to the institution, affiliating body/State Government and all others concerned accordingly".

NOW THEREFORE, Recognition of SHRI SANSKARDHAM B.ED. COLLEGE, 8. RAIL NAGAR-3, BAJRANGWADI MAIN ROAD, JAMNAGAR ROAD, RAJKOT, GUJARAT for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit of 50 students each) is permitted to continue.

The terms and conditions shall remain same as mentioned in the revised recognition order issued vide order dated 31.05.2015.
